<u>Class Description</u>: Prerequisite: none. This course helps new F1 Visa students gain an understanding of the critical elements involved in living and studying successfully in the United States of America. In addition to becoming acquainted with USIS regulations affecting International Students, the class will discuss graduation and transfer requirements as well as scholastic regulations at Glendale Community College, i.e. probation, grading policy, etc. A Student Educational Plan (SEP) will also be developed in class.

- 2. explain the college's academic regulations and understand immigration regulations affecting their F-1 visa status.

- 5. explain the College's academic regulations.
- 6. compare and contrast all the specific requirements in order to transfer to the UC, CSU, or ICUC systems.

4. Student will demonstrate knowledge of courses required, with appropriate sequence, to initiate a SEP.

Grading: There will be no **letter** grades; grading is either **Pass or No Pass**, based on:
