

- CCC lost about \$1.5 billion in state funding
- Eliminated 100,000 courses
- Shut out 500,000 students



General Fund and Education Protection Account Combined


General Fund and Education Protection Account Combined

State Budget Framework K-12 & Higher Education

- •Push decisions down to the local level K-12
- •Decrease time to completion; improve overall completion rate/improve transfer rate to colleges/universities Hi Ed
- Continue to pay down the "wall of debt"- both
- •Require income verification related to financial aid CCC

Multi-Year Education Plan?

State Budget Framework Higher Ed Stakeholder Mtg

- 1. Colleges need predictable funding
- 2. More investment in student support at both the pre-entry and entry levels to the colleges
- 3.Build on SSTF and the metrics established by system, INCLUDING THE NOTION OF EQUITY IN OUTCOMES
- 4. Colleges need local flexibility to best serve their students
- 5. There must be alignment across all segments.

Multi-Year Education Plan?

CCC Proposition 98 Manage Expectations

- Prop 30 Temporary Taxes
- •2013-14 Prop 98 Under appropriated
- Restoration Pressures
- Local Revenue Shortfalls
- •New Playbook in K-12 LCFF
- CalPERS / CalSTRS / Affordable Care Act
- Lurking policy initiatives

Prop 30 sale taxes trigger off in 4 yrs; PIT triggers off in 7 yrs

Proposition 98 Distribution of P-98 Resources

- •2012/13 CCC did NOT receive statutory split (10.55% equated to about \$200 M LESS than split)
- •K-12 Common Core vacuumed up the one-time funds
- •Adult Ed unsolved \$25 M regional consortium; promise of \$500 million on the horizon
- •K-12 Career Pathway Innovative grants (\$250 M)

Where are the incentives to collaborate?

2013-14 CCC P-98 Summary of Adjustments

•\$89.4M 1.63% Enrollment Restoration/Access/Growth

•\$87.5M 1.57% COLA

•\$50M Student Success/Matriculation

•\$47M Energy Efficiency/Prop 39

•\$25M Adult Education

•\$15M/\$15M DSPS/EOPS

•\$16.9M Online Education

•\$8 M CalWORKs

- •Focus upon the largest system of higher education; most diverse and socio economically challenged

- LCFF initiated the conversation
- "Equal treatment for children in unequal situations is not justice" Governor Brown
- Moral imperative
- Economic imperative

What role does the State play?

Where are Things Headed for 2014-15? Assuming Same Governor...

- Performance Metrics?
- Adult Education
- •Differential Funding AB 955

Can CCCs and Governor paddle in the same direction? Legislature too?

Opportunities / Challenges System budget request:

- •COLA \$240 M premised upon a super cola
- Categorical Restoration \$150 M \$50 for student success
- Access / Enrollment Growth \$110 M 2%
- Deferral Buy-down \$100 M
- One time Funds MAXIMUM AVAILABLE

Expect a robust package of proposals in the January budget

Opportunities / Challenges Where do we go from here:

- January 10: Constitutional deadline for Governor to present budget
- June 15: Constitutional deadline for Legislature to send budget to Governor

Expect a "normal" process and a relatively "on time" budget
