2. **Accreditation Gap Analysis: Progress Reports**  
The gap analysis is a tool for identifying gaps between current processes and the accreditation standards. This regular item on the IPCC agenda refers to discussion of progress on addressing the gaps.
3. **Process for Urgent Resource Requests**  
The IPCC established a process for urgent resource requests that occur outside the regular program review cycle but the process was never approved or moved forward. Questions and concerns are still being raised. IPCC should look at the process again, make improvements it finds necessary, and propose how to improve the college community's understanding of the process.
4. **Resource Request Processes: Appeals / Handling Recommendations of "No"**  
IPCC should clarify how resource requests that are turned down should be handled, and if there should be a way to appeal the recommendations coming out of the resource allocation process.
5. **Institutional Effectiveness Report 2013-2014**  
Ed Karpp will present an expanded version of the Institutional Effectiveness Report that has been published since 2010. The new version focuses on collegewide effectiveness measures tied to the mission, the EMP, and institution-set standards.
6. **Addressing Concerns with Resource Request Ranking Procedures**  
The Governance Review Committee has expressed some concerns about how resource requests were ranked in at least one standing committee, including that less than half of the committee members rated the requests. IPCC should look at the process and make recommendations to improve it.

7. **Strengthening Link Between SLO/PLO/ILO Assessment and Planning**  
One part of integrated planning that could be improved at GCC is the link between assessment and planning. IPCC should discuss this and recommend a process to strengthen the link.

8. **IPCC Mission Statement Annual Review for 2014-2015**  
IPCC should review its mission statement and revise it if necessary, in accordance with governance procedures.
9. **IPCC Chair for 2014-2015**  
IPCC should select its chair for 2014-2015, in accordance with governance procedures.
