SUBJECT: APPOINTMENT OF MEASURE G BOND OVERSIGHT
COMMITTEE MEMBERS

DESCRIPTION OF HISTORY / BACKGROUND

Measure G was approved by the voters of Glendale under the provisions of Proposition 39. One of the provisions of Proposition 39 is the establishment of a citizen's oversight committee to oversee the management of bond funds. Members of the committee may serve two terms of two years each. Three members of the Measure G Bond Oversight Committee will be terming out this month leaving four active members. Proposition 39 requires that the oversight committee consists of at least seven members; and the Glendale Community College Board of Trustees established a policy of a maximum of thirteen members. Earlier this year, a request went out to the Glendale Community College Board of Trustees, Measure G Bond Oversight Committee members, the Glendale College Foundation, and the Associated Students for potential nominees. The following individuals have applied for appointment to this committee:

- 1) Mr. Greg Astorian: Mr. Astorian is a commercial realtor who has been very active in the community. He is a Planning Commissioner and is a member of the Glendale Chamber of Commerce, Kiwanis, Workforce Investment Board and Salvation Army. He is a Certified Investment Member with an understanding of construction budgeting. Both of his children have graduated from Glendale College.
- 2) Mr. Armik Avedisian: Mr. Avedisian is a realtor with many years of experience in construction, real estate law, and finance. He is a member of the Measure S Citizens Bond Oversight Committee, Board

of Directors of Glendale Association of Realtors, and Glendale Crime Stoppers. Previously, he served on the board for the Salvation Army and Glendale Armenian National Committee.

- 3) Mr. John Kociemba: Mr. Kociemba is retired. He is a board member for the Pelanconi Estates homeowners association and the treasurer for the Glendale Homeowners Coordinating Council.
- 4) Mr. Kevin Lee: Mr. Lee is an accountant who has recently moved into the Glendale area and wants to get more involved in the community. His expertise is in preparing and reviewing financial statements.
- 5) Mr. Luis Sosa is a realtor who specializes in the sale of single-family residences and income property. He is a member of various realtor organizations within the city and the Glendale Elks Lodge No. 1289. In addition, he is a board member for the Glendale Police Foundation and Glendale Crime Stoppers.
