End-of-Year Status Report

- 1. Board members primary attention is on issues related to the four Strategic Goals in the GCCD Educational Master Plan: 1) students awareness, access, persistence and success, 2) economic and workforce development, 3) instructional programs and student services, and 4) fiscal stability, diversification, and enrollment management; and to facilities and institutional operations.
 - Provide oversight and support to increase enrollment so as to serve the education and job training needs of the community and assure the fiscal stability of the college
 - ✓ Monthly information reports provided to the Board on enrollment
 - ✓ The college achieved a 10.3% increase in state apportionment FTES enrollment for 2016-17 including 556 FTES from Summer Session 2017 enrollment.
 - ✓ The college's enrollment management efforts resulted in the college returning to its state base funding level, being eligible for its state maximum growth funding of .5%, and no longer using the state's stability funding mechanism.
 - ✓ While the college used 556 FTES Summer Session 2017 enrollment to achieve base funding and .5% state growth funding it has a projected 882 FTES for use in 2017-18 school year calculations for state enrollment appropriations.
 - ✓ To achieve enrollment base funding for 2017-18 and be eligible for .5% growth the college will need to grow approximately 4.2% (633 FTES) from its 14,985 actual 2016-17 level to 15,618 in 2017-18.
 - Maintain oversight of the college budget including an expectation of timely informative meetings, the setting of budget benchmarks, and five-year budget projections

- ✓ Preparing the RFA for the Zero Textbook Cost Degree Grant from the Chancellor's Office—Social Sciences has developed a Z-Degree in Childhood Development that will be used in this application. Grant application due September 28th.
- ✓ Collection of OER materials has been created and made available in the library.
- ✓ Courses with no cost textbooks are identified in the schedule of classes. A second note indicating low cost text (under \$40) is being worked on.
- ✓ Faculty Development Office providing further learning opportunities on the use of OER
- Review the GCC vision for online education and consider what appropriate policies and support are necessary to assure its effective use in fulfilling the college mission
 - ✓ Separated the Distance Education Coordinator into two positions in order to focus on two areas: evaluation, growth, and planning of Distance Education and supporting faculty with pedagogical and instructional support in an online environment
 - ✓ New Distance Education Coordinator (50%) selected. The second 30% position is still being written.
 - ✓ Transition to Canvas Learning Management System (LMS) completed. Transition from Turnitin to Vericite also completed
 - ✓ Professional Development workshops on the use of Canvas and Vericite have been offered through the summer
