# V. Guided Pathways Update from Rachel Ridgway

- Presented 10 complete or near complete online/hybrid degrees to create DE Guided Pathways.
- Richard Cortes requested that we have a master list of DE classes organized by discipline to share with co-leads who will produce the first draft meta-major maps. They are targeting to meet in Win 18 to discuss these drafts before floating them by Divisions. – Emailed to Cortes on 11/22/18.
- Nov. 8th EAB-Navigate will be on campus to demo both the student-facing and counselor-facing interface. The issue was raised of how this will integrate with People Soft (and I asked about Cranium Cafe) - a meeting is planned to discuss these very issues sometime in November.
- Tom Voden says the pilot of Program Mapper web interface in might be available in Spring 2019.
- Need fully online Math Statistics and Calculus.
- Question: Do we want DE Hybrid and Online Guided Pathways or just Online?

# VI. OEI Steering Committee Update from Eric Hanson

#### 1. OEI update.

- Finish Faster update (there are 9,118 fully online courses this Fall).
- Most popular subject areas for further growth are in Math, Humanities, and Oral Communication. Statistics and Calculus are the most sought after online courses.
- No longer using the term "Late Start" for classes, but "Classes when you want them"
- See cvc.edu, there was a 124% increase in users of the new site in two weeks.
- New branding for CVC OEI and @ONE coming in January
- Andrea Hanstein says she spoke with all PIOs
- Only completely online ADTs will be included in the CVC, no hybrid or AA/AS degrees.

# New title 5 requirements for the DE Addendum

#### 55206. Separate Course Approval

If any portion of the instruction in a new or existing course to be provided through distance education, an addendum to the official course outline of record shall be required. In addition to addressing how course outcomes will be achieved in a distance education mode, the addendum shall at minimum specify how the portion of instruction delivered via distance education meets:

- (a) Regular and effective contact between instructors and students and among students as referenced in title 5, section 55204(a), and
- (b) Requirements of the American with Disabilities Act (42 U.S.C. § 12100 et seq.) and section 508 of the Rehabilitation Act of 1973, as amended, (29 U.S.C. § 749d)

The addendum shall be separately approved according to the district's adopted curriculum approval procedures.
