ITEM 1: PROGRAM GOALS AND OBJECTIVES

This skill award is designed for students preparing for the Ethics requirements on the CPA exam.

ITEM 2: CATALOG DESCRIPTION

As required by the California Board of Accountancy, when a CPA candidate has successfully passed all four parts of the CPA exam, he/she must meet additional educational requirements of 10 semester units in ethics studies prior to applying for a CPA license. This 4 course (in total 12 units, which contains 10 ethics units) skill award is designed for students preparing for the Ethics study requirements. Nine of the ethics units are provided by ACCTG 165, 235 and 250, while ACCTG 225 provides the remaining 1 ethics unit for a total of 10 units.

This 10-unit skill award is designed to prepare the student for the IRS Enrolled Agent program and Regulation portion of the Certified Public Accountant exam.

This 4 course, 10 unit skill award is designed to prepare the student for both the IRS Enrolled Agent exam when coupled with Accounting Certificate. This award will also prepare the student for the Regulation portion of the CPA exam and can be used as accounting or additional business classes toward the required 24 units in each accounting and business related subjects.
