WHAT IS CALFRESH?

CalFresh, also known as food stamps, is a nutrition assistance program sponsored by USDA that helps people purchase healthy foods. Benefits are loaded on an EBT card, which functions like a debit card that can be used at most grocery stores!



DEFINITION OF A CALFRESH HOUSEHOLD:

An individual or group of people who **buy**, **share**, **and eat food together**. The people in a household do not have to be related to each other.

DO I QUALIFY FOR CALFRESH?

Students (ages 18–49) enrolled at least half time (6 units), or meet the Gross Monthly Income Limit, and meet **at least ONE** of the following conditions:

- Employed at least 20 hours a week
- Enrolled in/receiving work study or participating in a similar program
- Care for a child age 12 or under
- Do not plan to register for the next term

- If you are under the age of 22 and live with your parents, you must include them in the application
- At least ONE person in the household must be a U.S. Citizen or a Legal Permanent Resident



WHAT DOCUMENTS DO I NEED TO BRING?

- ID for all adults in the household who are applying
 - Driver's License/Passport or Green Card
- 2. Social Security Card(s)
- 3. Proof of Income from the previous month
 - Earned Income: Pay Stubs
 - Unearned Income: Pension, Social Security Award Letters, Retirement Income, Disability Statements, Veteran's Benefits
- 4. Proof of Living Expenses
 - Rent, Utility bills, Phone bill, Medical Expenses
