4. Superintendent/President Search Update

Viar introduced Dr. Ben Duran and Dr. Lisa Sugimoto of PPL, Inc. to provide information regarding the Superintendent/President search process. Duran indicated the hiring committee had met to discuss their roles, responsibilities and confidentiality as a member and that candidate recruiting had begun. Sugimoto noted outreach to appropriate candidates had taken place and is moving forward. Sugimoto noted it is not uncommon for applicants to wait until the application deadline (January 31, 2022) for confidentiality reasons. Appreciation was shared to the GCC Communications and Community Relations staff for their work in making the Superintendent/President search webpage informative, thorough and easy to navigate.

5. Report from Glendale College Foundation Task Force on Capital Campaign Feasibility

Glendale College Foundation Executive Director, Lisa Brooks introduced Capital Campaign Task Force member, Ellyn Semler, who highlighted the mission of the Foundation to create public awareness of the needs of the college, promote the college to business/industry and the Glendale community, and raise funds for facilities and programs. To assist the college raise funds for three of its major facilities priorities: Athletics, Science, and Performing and Media Arts. Ms. Semler announced the Foundation would engage in a three-year phased effort to raise at least \$1 million to provide equipment enhancements and provide an operations endowment for each of the three areas. She detailed the findings of the feasibility study conducted to identify what needed to be done for a successful campaign and actions now underway.

6. Federal and State Relief Funding for Pandemic Related Costs at GCC - 2020-2022

Culpepper presented a status report on the \$67.4 million received from the State and Federal government to address COVID-19 issues and detailed how the funds were being used for direct student-related support, mitigating lost revenue due to the pandemic, providing instruction and student services in a remote environment, assuring prevention and mitigation of the virus, and supporting needs of college personnel.
