Dr. Culpepper presented highlights on a variety of Measure GC Facilities projects to include the Kinesiology/Vaquero Athletic Complex, Garfield campus projects, and planned New Science Building (NSB) and David Viar Performing and Media Arts Center. On Wednesday, April 27th, a Topping Out ceremony is planned for the NSB project. Culpepper provided information on the budget for these projects noting plans to bring down escalating costs and holding on the enhancement of the PDC Montrose campus (currently maintaining the site). The current budget is shown below.

Even after his retirement when he moved to Philadelphia to be near his children and grandchildren, he found another full-time math position at a local community college and went through the tenure process all over again.

Sid's career at GCC was illustrious. He received the Distinguished Faculty award in 2004 and served as the Academic Senate President from 2005 to 2007. For many years, he coordinated the Science Lecture Series, and Sid had over 100 articles published in math and education journals over the course of his career. In 2010, the year he retired from GCC, he received the Gerald Hayward "Excellence in Education" award from the California Community College's Board of Governors.
