Call to Order

Approval of Minutes

I. <u>Announcements</u>

II. Ongoing Business

Update on migration to eLumen. Nancy is completing the data transfer. There are missing data from CMS, which Nancy had to retrieve individually from PeopleSoft. C&I reps will have to check the integrity of the information when eLumen is operational. There was a meeting earlier today with Megan Blevins and Melissa Kibrick from eLumen and C&I committee members to discuss dashboards, workflows, etc. The workshops listed below have been scheduled with Megan. The role of C&I in promoting DEIA. Yvette and Francien conducted the last of the spring semester's workshops, Creating Equitable Learning Outcomes on May 5, which was well attended. Francien is planning to have at least two workshops in the Fall, perhaps discipline specific. Please contact her if you would be interested. Please send her samples of assignments or activities for our collection of DEIA curriculum materials.

III. <u>New Business</u>

Articulation Update (Cortes). Richard shared the March 7, 2022 memo from Robert Horwitz, Chair of the Special Committee on AB 928 (Student Transfer Achievement Reform Act of 2021) addressed to ICAS (Intersegmental Committee of the Academic Senates) regarding the recommendation on a singular GE transfer pathway. The new pathway's requirements are:

- UC will accept Oral Communication as a new (third) course in Area 1-English Communication.
- The CCC will revise and strengthen courses fulfilling the Oral Communication subject requirement to meet new core competencies.

- The number of courses required in Area 3 -Arts and Humanities will decrease from three to two (one in Arts, one in Humanities).
- UC will remove its Language Other than English proficiency requirement from IGETC and treat it as a graduation requirement.
- CSU will remove its Lifelong Learning and Self-Development course from IGETC and treat it as an upper-division requirement.

Richard showed the differences between the current requirements for each area and the new proposals, analyzing their impact on student transfer, graduation, enrollment, etc. AB 928 will go into effect in 2024. There is still time to express your concerns and recommendations. Please contact Richard or Academic Senate president Roger Dickes. Richard would be happy to talk to your division. Francien sent a copy of the memo to the committee.

Richard later sent an email to all faculty and administrators with a Zoom link.
