Drake Hawkins was a pillar in the history and development of Glendale Community College. In addition to serving as Professor of Political Science from 1970 to 2001, Drake had many campus-wide impacts. He was instrumental in helping the college separate from the Glendale Unified School District, and in the establishment of our own union, the Glendale College Guild. Drake also served as Division Chair for Social Sciences from 1985 to 2001. In 1999, he was awarded the William L. Parker Award for institutional service. Over the course of his 31-year career, Drake impacted the lives of countless students and employees. Drake's legacy of helping to build a college where faculty voices are celebrated and respected as an integral part of governance cannot be ignored. Drake was 80 years old when he passed away.
