Call to Order: The meeting was called to order by Ed Karpp at approximately 12:15 p.m.

- I. Approval of Minutes
 - a. The minutes from April 11, 2022 were reviewed.

- III. Accreditation Work Groups Update and Timeline
 - a. Writing teams are mostly done.
 - b. All drafts are in the hands of reading teams.
 - c. Some of the drafts have gone to Governance Committees. Some drafts are awaiting additional information before going to Governance Committees for input.
 - d. June 1, 2022 is the deadline in place for feedback.
- IV. Enrollment Update
 - a. Winter down 5%
 - b. Spring down about 17% for Credit.
 - c. Spring 2022 for Noncredit numbers are back to 2019 numbers.
 - d. Summer registration has started but it's too early to say much about the numbers.
 - e. Fall Priority enrollment starts soon for credit.
- V. Vaccine Mandates Effects on Planning
 - a. Paul Schlossman gave an update.
 - b. Discussions are being had on changing the mandate.

- c. We are currently looking at what neighboring institutions are doing re: Covid Related Policy, Mask Mandates, and Vaccine Mandates.
- VI. Governance Review Recommendation: Permanent Zoom Link for Committee Meetings and Posting of Agendas to Remain Compliant with the Brown Act.
- a. This topic stems from a Governance Review discussion that those who want to attend a meeting as guests do not have access to location/meeting links if they are not on a committee but want to attend.
 - i. Standing room links would make it easier for individuals to attend committee meetings they are not members of.
 - ii. Governance Review is going to do a pilot and see how this works.
 - 1. English Division currently has a Zoom room.
 - b. Governance Committees are not Brown Act Committees
 - c. Questions include:
 - i. Who will have controls over the room?
 - ii. How would scheduling/prioritization of an open room work?
 - iii. Will there be a designated host that can mute everyone?
 - iv. What are the security issues with an open Zoom room?

New Business:

- VII. New Institutional Set Standards approved by the Senate
- a. Senate approved some new Institutional Set Standards.
 - i. No change on Course Completion.
 - ii. Retention was lowered back to 47% where it had been before (pre-Pandemic value)
 - iii. Degree Completion was approved for 1100 as the base and 1400 stretch goal.
 - iv. Transfers were approved for 1100 as base and 1400 for stretch goal.
 - v. There was no change to certificate completion.
- VIII. Review of Standard I Section of ISER Draft
- a. Standard I: Mission, Academic Quality, and Institutional Integrity was reviewed.
 - b. IPCC is the appropriate committee to review Standard I and is therefore committee members are being asked to review and provide input to Daphne Dionisio by June 1, 2022.
