- III. Accreditation Work Groups Update and Timeline
  - a. A High-Flex presentation was reviewed at Institute Day.
  - b. Fall 2022
    - i. Getting ready to send out Draft of ISER to Standing Committees for review.
    - ii. Will also goes out to Senate, ASGCC, CSEA.
    - iii. Will be sent to Accrediting commission in December 15, 2022
  - c. Collecting and linking evidence needs to be completed.
  - d. Accreditation Steering Committee meeting next Friday to weigh in on logistics of the planning that's going to be happening primarily regarding the on-site visit.
- IV. Enrollment Update
  - a. Fall 2022: well below where we were last year and the previous 3-4 years.
  - b. Fall 2022 is down 14.2% from last year in Credit.
  - c. Noncredit is up 28% from last year than it was last year at this time.

- V. Vaccine Mandates Effects on Planning
  - a. Admin Exec has discussed revising the vaccine and masking mandates.
  - b. Any changes to BP needs to go to the October 2022 Board so message can go out before the spring Priority registration.
  - c. No changes in policy for winter.
  - d. ASGCC working on getting student input via a Student Vaccination Survey
  - e. Question was raised as to whether the Board has to act on the Mask Policy?
    - i. No, it's not part of the Board Policy.

  - a. *The IPCC models and monitors continuous quality improvement to ensure institutional effectiveness. The committee oversees college planning and program review; assesses the effectiveness of planning; makes recommendations for sustained quality improvement; develops strategies to promote college-wide dialogue and participation in the integrated planning process; and identifies trends that reveal institutional and student needs. These objectives are achieved by the strategic use of institutional data (including program review), accreditation standards, federal and state regulations, and community input as guiding principles for assessing institutional effectiveness.*
