

STUDENT EXPECTATION IN MEDIA ARTS

DEPARTMENT OF MEDIA ARTS REGULATIONS:

It is the policy of GCC Standards of Student Conduct that all rules and regulations specified in the **Administration Regulation Code 5500** are adhere to by all students while working on any GCC production on the GCC property or on a location off campus.

Some (but not all) of the safety, code includes:

- All on and off campus production must be approved and permits must be obtained before any production begins.
- Any use of any firearms, pyrotechnics or fire in any GCC production or assignments is prohibited.
- Any use of prop weapons, fake weapons or implied weapons in any GCC production or assignments are prohibited.
- Any animals in any GCC production or assignments is prohibited.
- Any use of moving vehicles (camera onboard or not) in any GCC production or assignments is prohibited.
- Proper closed footwear will be worn at all times by all the members of the production crew.
- Proper safety equipment will be use with the use of any and all electrical equipment, including by not limited to the use of fully grounded extension cords, never overloading any electrical circuit, heavy gloves when working with lighting instruments, proper use of department lighting kits.
- Production crews will not work for more than 10 hours in any given 24-hour period. During that 10 hours of production there must be two meal breaks and two 15-minute rest breaks.
- No drugs, alcohol or illegal substances can be on the production location or used during the production day with any and all GCC production assignments or projects.
- No food or drink are allowed in any of the production studios, editing suites or audio rooms.

It is the policy of GCC that all the following rules and regulations are to be adhered to by all Media Arts students, their talent, actors and any guests in any GCC classroom, studio or on a location environment, on or off campus.

- Following all directions, instructions or orders given by the class professor or GCC staff member.
- Follow all direction, instructions or orders given by the assigned student Producer or Director.
- Work in a collaborative manner with assigned or chosen production team members on classroom productions or assignments.
- Fulfill all necessary duties, responsibilities and obligations of assigned production positions.
- Follow all of latest Department of Film, TV and Media Arts Department Covid-19 Safety Guidelines.

GCC STANDARDS OF STUDENT CONDUCT FROM 2021/2022 CATALOG PAGE 53-54 AND ADMINISTRATIVE REGULATION 5500

Prohibited conduct that may subject a student to disciplinary sanctions included, but is not limited to the following:

Disruption of the orderly operation of the college including, but not limited to the delivery of GCC instructional, administrative, or student services programs and functions; campus activities sponsored or sanctioned by GCC; other authorized non GCC activities when the act occurs on GCC

- premises. Disruptive behavior, willful disobedience, habitual profanity or vulgarity, or the open and persistent defiance of the authority of, or persistent abuse of GCC employees.
- Violation of published GCC rules, board policies, and administrative regulations.

For any violation of the Media Arts Department guidelines and the GCC Standards of Student Conduct, a student conduct incident report will be submitted to the Office of Student Affairs. Such violations of the college's student conduct policies may lead to immediate dismissal for up to two class sessions while disciplinary conduct is addressed, which may lead to course dismissal.
