- Yvette will not send whole lists because people either don't read them or they get confused. She'll send individually to departments and coordinators.
- Using attainment, skill and unique PLO model, May 5th at 12pm. Written in a way that faculty and students understand them. As with Guided Pathways students will be able to read them. Eliminate confusion of convoluted PLOs. We'll do a fall session as well.
- We want to ensure we have the info we need to look at the data for assessment. Not every SLO need to map to PLOs. We want the focus on the PLOs that help us gather curriculum data for our departments.
- All information to help faculty upload was sent out after spring break.
- The questions should help departments see what we discover about the curriculum: what we want our students to know in a specific program and which groups are or are not hitting targets. Our responses to questions can address needing new certifications, PLOs or address impacts of Covid.
- Yvette will review starting Monday the 16th.
- Mapping event really well and do believe it has started many discussions regarding PLOs and SLOs. More to come. (Show PDF of mappingsee examples Math and KIN)) Feedback was that it was easy and they understand how to map. As LOA reps, we'll continue to be able to Map. C&I will be seen in curriculum (like changes to SLO) and the changes will be updated immediately. All changes must still go through C&I but the process will be faster.
