Ruben was Saodat Aziskhanova's husband. He suffered with a terminal illness that took his life on Saturday, May 13. Ruben was surrounded by his family and we grieve their loss with them. We share our deepest condolences to Saodat, and her three children Karina, Garen and Christine, who are all GCC alumni.

Ms. Ransford shared that Larry Hanson was an incredible friend of many, but especially Glendale Community College. Larry never wanted or needed to be out front, but rather in the background finding projects that needed doing. He joined the Foundation Board of Directors in 1991 following his retirement from IBM and served on the Board for 31 years. During that time, he helped establish the El Vaquero Racket Club that to this day raises funds for the Foundation and served on the Finance Committee for many years always providing thoughtful insight. Larry created a Donor Software and Endowment Tracking System for the Foundation and sold it to College Foundations throughout the country donating the proceeds to the Foundation. Recently, he helped organize the Foundation Legacy Society.

Not only did Larry help raise funds for the Foundation - he was one of the most loyal donors. Supporting every event and program including one of the first persons to set up a Charitable Gift Annuity and when his wife Lyle passed away he made a substantial contribution to establish a scholarship in her name every year personally interviewing the students. And if all that wasn't enough he served for over 8 years as a member of the Glendale Community College Bond Oversite Committee. While Glendale College was the major focus of his volunteer activity he also included the Campbell Center, the LA Chapter of the Sierra Club and the Verdugo Woodlands West Homeowners Association.

It's easy to say, but hard to do - that is miss Larry. He leaves behind his daughter and son-in-law Karen and Scott Allison, granddaughters Eva and Hannah, and his longtime partner Beryl Adams. With great honor and sadness we adjourn the June 20, 2023 Board of Trustees in memory of Larry D. Hanson.
