#### II. Ongoing Business

eLumen Update. Nancy is working on programs and plans to complete them over the summer. She will create a training video of tips and tricks for courses. If you would like to share tips that you have discovered, please email Nancy.

DE Designation in CORs (intent to offer a course 100% online). In eLumen the last tab for courses is "Curriculum Specialist/AO Approval." It has a DE section on the right with two questions. The first asks whether the course is DE approved. The second question asks, "Will this course be taught asynchronously?" As it relates to programs, it asks whether the class will be offered with an online section, which could potentially be an online class in a program. Nancy showed how the percentage of DE courses filters to a programs page.

Since the boxes on this tab can only be checked by Nancy and Bridget, Nancy will be referring to you. Please discuss this at your division meetings and ask if the division plans to offer an asynchronous section of a course at least once a year. The COR will not have to go through C&I again. Please let Nancy know in an email.

Piper reminded the committee that the reason we have to be able to guarantee if the course is actually going to be offered at least once in an academic year (for courses which are required to obtain an AD-T) is we publish an online pathway in the California Virtual Campus. A student has to be able to complete the AD-T through the online pathway in a 2-year timeframe. We have to show that we offer an online section of a class regularly. (ACCJC Standard II.A.1)

### III. eLumen Training

Preliminary and Tech Review Committees. Francien met with both Preliminary and Tech Review Committees to train the members on eLumen. The CORs are due to come through in late August.

Updating existing CORs in eLumen. Please remember to submit your proposals twice, first as a faculty member, and then as the C&I rep. If your division has multiple departments, Beth suggested adding faculty members as authors (after you've chosen the workflow) at the start of the process so eLumen could give them access to their department outlines. Changes could still be made before the second submission. This would be the ideal time to apply a DEIA mindset: Is the language in the catalog description inviting? Is there anyway the COR could be more inclusive in terms of text, or more accessible in terms of the assignments? Alexandra suggested using the USC-CUE Document Review, which she discussed in a previous meeting.
