REGULAR SESSION

Sally Holmes, Glendale Community College District's Superintendent/President and Board of Trustees Executive Assistant from 2006 to 2016, shared the following:

"This evening, I would like to share a few words remembering Dr. Audre Levy, GCCD Superintendent/President emerita, who passed away in December. I had the privilege of working for Dr. Levy during her tenure at Glendale Community College.

In 2006, the District employed Dr. Levy as superintendent/president, following the retirement of Dr. John A. Davitt. This change in the college's leadership was significant, as the new superintendent/president was following in the footsteps of a chief executive officer who had served in that capacity for twenty-one years. Moreover, Dr. Audre Levy made GCC history when the District employed her as its next superintendent/president. Dr. Levy was the first woman and the first person of color to serve in this role.

With sagacity, Dr. Levy valued the fabric of the previous administration, while incepting her own leadership style. With energetic vision, Dr. Levy introduced new approaches that took root during her three-year tenure, evolving after her departure and stylized by each ensuing superintendent/president.

Tonight, Dr. Levy, I would like to say thank you. It was an honor walking the path with you during your GCC years. Godspeed."

Thomas (TJ) Denton was warmhearted and had a loving zest for his family and service to the community, and looked on the many blessings of his life with gratitude.

Born to Thomas and Jean Denton and the brother of three older sisters, TJ grew up in Glendale. At Glendale High he was on the water polo and swim teams and enjoyed being a yell leader. He attended GCC and also studied graphic art at San Jose State and quickly entered his parents' business, Thomas Denton & Co., where he worked for over 30 years side-by-side with his best friend and beloved father, Tom.

TJ is survived by his wife Barbara; his daughters Emily Dickinson (Jeremy), Shelby MacDonald (Kyle), and Elizabeth Denton (Tom); granddaughters Althea MacDonald, and Olivia and Evelyn Dickinson; and sisters Laura Johnson (Carl), Julie Denton (Darwin), and Kelly Denton-Borhaug (Gunnar).
