## 5. Other

### a) Income Statement

Co-Chair Nour reviewed the quarterly statement of income and expenditures with a forecast of expenditures through June 30, 2024. These are not the final numbers as some of the adjustments made will take place in July, 2024. The second page of the Income Statement details the source of the funding: federal, state, local (student fees). The 3% raise is not reflected on the Salaries budget line item as April's numbers are not yet reflected in this

statement. In response to Alexandra Christy's concern regarding capital outlay numbers, Cochair Nour promised to check the numbers report back to the committee at the next meeting. Details of this Income Statement can be retrieved at glendale.edu/budget

## b) Financial Reporting

This is a summary of all the accounts associated with the unrestricted general funds. Fund 01 is the only budget line item. One should be able to access one's respective budget line balances at any time. Details of the latest Financial Reporting can be retrieved at glendale.edu/budget

### c) Cash Flow Statement

The Cash Flow Statement keeps track of monies coming in and out, to ensure the College has adequate funds to pay its obligations through the fiscal year. The numbers in Column L are final numbers, that is actual, whereas those in columns M through P are forecast. The expectation is that these numbers should stay the same. In response to Nusha Shishegar's request for an update regarding HEERF funding that the State is still holding, the Co-Chair said he hopes this will be disclosed at the May Revise. There is a deficit factor in the budget of approximately \$3.5 million. Incredulously, the state is trying to increase the COLA to 1.07% despite the current deficit.
