The Financial Aid census date for Fall and Spring semesters is usually the 5th week of classes. Consortium Agreements for Winter session will not be accepted until after the Financial Aid census date for the Spring semester. The Financial Aid census date for Summer session is usually the 3rd/4th week of classes. Current verification of enrollment must be attached to the Consortium Agreement. Current is defined as less than seven (7) days prior to the date the Consortium Agreement is submitted.

Consortium Agreements are only approved for one semester/session at a time. Consortium Agreements are not approved retroactively. To be eligible for payment, a completed Consortium Agreement and current verification of enrollment at the Secondary College must be received by the GCC Financial Aid Office after the Financial Aid census date and by the last day of the semester/session listed in the Student's Section of the form.
