1. College Executive Committee - Lilit Yerkanyan/ Carlos Matute

- During the College Executive Committee meeting, there was a 10% increase in enrollment, and efforts are underway to recruit a diverse pool of applicants for a new position. Additionally, \$800,000 has been allocated to cover costs for half the school year, and Blue Shield insurance premiums for faculty are expected to rise slightly, as usual. The first reading of BP 66800, a billing policy, was also mentioned during the discussion.

2. Governance Review - Carlos Matute

- During the governance review discussion, meetings will be held as needed, with a focus on graduation requirements and timing adjustments to increase participation.
- The Scholars Program governance committee is awaiting a representative, with seven volunteers, and a raffle will determine the final selection. A shared governance training session for non-officer committee members is scheduled, and Dr. Harnett will be informed of the representative's need to attend.

3. Curriculum and Instruction - Carlos Matute/ Lilit Yerkanyan

- There is a potential for additional requirements for AA and AS local diplomas, with Paul Vera expected to speak on the matter next week. These new requirements may not affect all students, and current students will remain under the catalog requirements they started with.
